Note: *Utah S.B. 39 Home School Amendments* provides that a signed and notarized affidavit shall remain in effect as long as:

- i. the school age minor attends a home school; and
- ii. the school district where the affidavit was filed remains the school age minors district of residence.

I accept full responsibility for the education of my school age minor and understand that he/she may not qualify for a high school diploma issued by the Granite School District or any of its schools.

(For students with IEPs or identified through child find): My decision to home school does not in any way imply that the school district did not provide a free and appropriate public education and I understand and agree that my student has no individual right to receive some or all of the special education and related services he would receive if enrolled in a public school in Granite School District, unless I have arranged for dual enrollment consistent with state law, Section 53A-11-102.5 and Utah State Board of Education rule, R277-438.
