**SUBJECT:** Hunter High School Change Order for the New Addition

Dear Dr. Bates,

Items identified below have required a change order to the original contract from Bud Mahas Construction for the Hunter High School addition. This work is needed to help maintain the continuity of the exterior building aesthetics and to help ease the interruptions to the school and the students.

## Modifications included:

- 1. Design drawings incorrectly identified the fire line loop as a 6" pipe, but code requires 8" piping.
- 2. At the north end of the site an isolation valve was added to the fire line loop to help with maintenance and emergencies.
- 3. The existing electrical transformer prematurely aged. As such, service and repair is required to adequately provide service to the school during construction.
- 4. An electrical piece of equipment called a sectionalizer (above-ground junction box) was needed now to help minimize the downtime of the power to the school as construction proceeds. The addition of this equipment allows construction to progress without substantial interruption (up to three days at a time) to the operations of the school. An additional benefit of the sectionalizer allows for easier maintenance in the future.
- 5. Unforeseen circumstances were encountered on-site as the existing electrical for parking lot lights did not match existing design drawings. Re-routing of electrical service was required.
- 6. Unforeseen circumstances were encountered on-site as the existing electrical for the electrical at the stadium, including lighting and other services did not match original drawings. Re-routing of electrical service was required.
- 7. The District originally planned to salvage the original flag pole. After salvage occurred, it was determined that structural integrity and general condition of the flag pole would not allow for salvage and re-use. The District has opted to replace the flag pole.

8. Cost to change from concrete masonry units (CMU) to brick to blend better with the existing building.

This work and scope change resulted in a change order request in the amount of \$175,002.01.

This work is important to help the contractor minimize the down time and disruptions to the active school, which is best for the students and patrons at Hunter High School.
