- July 15,16 & 20 School Plan Template Trainings provided by School Leadership and Improvement Directors
- July 31 Plans Due to School Leadership and Improvement Directors
- August 5 Plans Posted to School Websites
- August 17 24th Train Faculty and Staff
- First Week of School and ... Admin, faculty, and staff train students

Risk Mitigation – Situational Characteristics

- Face Coverings The best mitigator
 - Required for employees
 - Provided for every employee
 - Face shields for specific situations/needs
 - Required for students while riding the bus
 - Provided to students
 - Required for students while in school when social distancing is not practicable
 - Provided to students



Enhanced Environment Hygiene and Safety

- Protocols for increased cleaning and hygiene regimen
 - Intervals of thorough cleaning
 - Classrooms, Restrooms, Gym, Cafeteria, Commons, Media Center, Office, Playground, Etc.
 - High touch surfaces
 - Lockers preferably not used
 - Doors should be propped open
 - Equipment
 - Drinking fountains not used, preferably bring water bottles
- Employees and students wear face coverings
- Hand sanitizer, disinfecting wipes, soap and water, readily available
- Health and safety procedures part of regular instruction



Attendance Plans

- Regular Schedule
 - Traditional calendar approved by the Board of Education
- Dismissal Schedule If required/recommended by Governor or HD
 - Similar to 4th quarter 2020
- Modified Schedule If required/recommended by Governor or HD
 - Monday Thursday
 - Students divided in half alphabetically in each network
 - Half attend Monday and Wednesday, half attend Tuesday Thursday
 - Fridays are distance learning

All schedules share a component of distance learning



Distance Learning Challenges

- Professional development
- Resources and tools
- Access for all students
- Planning time for teachers



Current Planning Time

- Secondary teachers
 - Approximately 50 90 minutes each day
 - Late Start Mondays or Early out Fridays each week for PLC
- Elementary teachers
 - Approximately 2 hours per week
 - Limited PLC time twice a month



Consideration For Elementary

- Regular Schedule
 - Designated face to face teachers and distance learning teachers
- Modified/Dismissal Schedule
 - Teachers would need to be able to transition into distance learning



Designating Elementary Teachers as Face to Face or Distance Learning

- Parents/students would need to declare/commit to one modality for the quarter
- Teaching assignments would be determined by principal
 - Selected based on criteria
 - Teachers will report student metrics to their administration regularly
- Teachers, regardless of assignment, would be expected to work from school
 - PLC's, faculty meetings, parent and student meetings etc.
