Summary of January presentation

- Federal Law provides some flexibility to LEAs in determining which schools receive Title I money.
- Since 2013, GSD has used "elementary projected feeder pattern" data to qualify Granger High.
- With Cottonwood High School's recent Title I designations, all other schools receive less money.
- Internal GSD research shows that achievement is not primarily influenced by money.
- The question explored was "is a K-8 funding model or a K-12 funding model more effective?"
- Switching to a K-8 model allows for three options to increase funding to other eligible schools.
- After research and deliberation, my department's recommendation is the K-8 funding model.
- The rationale for a K-8 model is that early intervention is the biggest return on investment.

The Initial Question Before the Board

"In determining the poverty rank order for schools in Granite School District, shall the data used by the Board to measure poverty for high schools be the high school's own Free and Reduced Lunch percentage, or shall the data used to measure poverty for high schools be from the poverty levels projected from their elementary schools?"

Or, phrased as a yes-or-no policy question:

"For the purposes of determining Title I eligibility, shall the Board continue to measure poverty in high schools based on a projected feeder pattern?"

High School Student Impact

- The two high schools are serving 4,800+ students.
- At-risk enrollment continues to increase at each school.
- Money targeted toward engaging parents and increasing community support for their students' learning.
- When students enter high school with an educational deficit, extra supports are crucial to help students graduate.
 - Paraeducator support in classrooms
 - Credit recovery
 - After school programs
 - Reading support
- Title I monies have led to an increase in graduation rates and ACT composite scores.

High School Staff and Student Impact

- Title I counselor serving 366 students on their path to graduation and college and career readiness.
- 5 math bilingual support staff in classrooms.
- 2 bilingual parent liaisons for community support.
- 3 instructional coaches supporting teachers.
- 4 new teacher mentors supporting an average of 18 new teachers a year.
- 1.5 social worker for social and emotional support.

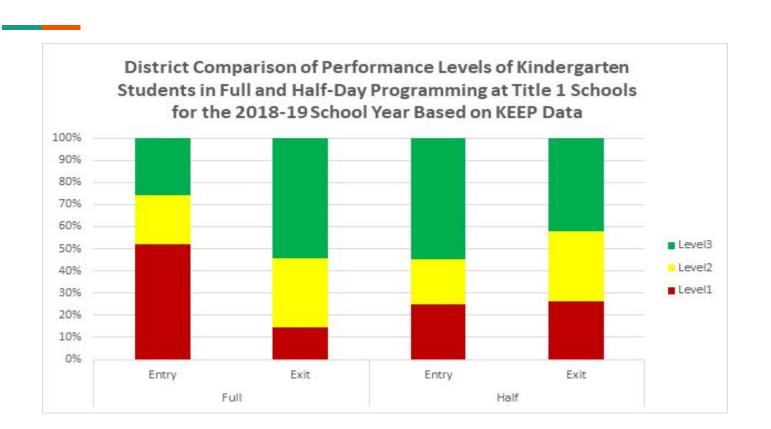
