

Gymnasium floor has been acclimating to building temperature and humidity.


Field Turf mobilized the week of 04/04/22.

Tiling at bathrooms and pool is ongoing.



Pool footing has been installed, excavated and filled in with structural fill dirt and made into a crane path for tilt panels.

Geo Energy drilling will be ongoing for the next year.

Building footings have been installed, underground plumbing and electrical installation are ongoing.
